Approved Minutes

The regular monthly meeting of the Manistee Township Board was held on Thursday, May 11, 2023 at 7:00 P.M. Board members present were Trustee John Dontz, Trustee Guy Finout, Treasurer Connie Jankwietz, Clerk Dianne Taylor, and Supervisor Dennis Bjorkquist. Also present were Deputy Clerk Heather Taylor, Zoning Administrator Karen Clouse, Fire Chief Joe Cerka, Liquor Inspector Rick Clouse, Barry Lind from PEG, Dan Edgington, and Gary Madden.

Supervisor Bjorkquist called the meeting to order. All attending stood and said the Pledge of Allegiance.

Trustee Finout made the motion to approve the April 13, 2023 Regular Board Meeting minutes and the April 28, 2023 Board Work Session minutes as written; seconded by Trustee Dontz. All in favor; motion carried.

Approved Manistee Township Planning Commission minutes from the April 12, 2023 Regular Meeting and April 19, 2023 Work Session were received and placed on file.

Manistee Township Zoning Board of Appeals did not meet.

Treasurer Jankwietz gave the Treasurer's report for the month of April 2023. The receipts were \$1,718.00; expenditures were \$69,180.42, leaving a balance of \$47,473.51 in the General Fund as of April 30, 2023. The report was placed on file.

County Commissioner, Jeff Dontz, was not available for a report.

Zoning Administrator Karen Clouse reported on the activity in the Zoning office. There were no new complaints. The office issued one (1) zoning permit and received fourteen (14) requests for construction permits. InstaLaunch has installed a stop sign at their entrance/exit. Michigan Self Storage facilities is expected to begin their project this month on the corner of US 31 and Kemmer Road. Work sessions are being held by the Planning Commission, Trustee Finout, and Zoning Administrator Karen Clouse to discuss potential amendments to the Zoning Ordinance.

Fire Chief Joe Cerka reported there were six (6) medical related, four (4) fire related, and twenty (20) lift assist calls during April. The Chief and Officers had 60 hours total. There were no community events for the month of April. Ladder Truck 131 went in for full service and is done; Truck 132 will be going in next. Keeping the station and apparatuses clean. The Local Revenue Sharing Board will award grants in May. We did not receive the AAA grant; the fire department is looking into other grants. The department completed a couple Lexipol programs for training. Two people have expressed interest in joining the fire department. There will be an open house on August 5, 2023 starting at 2pm to celebrate 50 years of service. Liquor Inspector Rick Clouse reported all licenses have been posted.

Supervisor Bjorkquist mentioned the road repair on Siuda and Polen Roads is behind due to the weather; repairs will be starting soon. Will be reviewing the contract later in the meeting for upcoming repairs to Hill Road. The Friends of Orchard State Park have been awarded \$300,000.00 from the Michigan Land Trust Fund but the legislature has not passed the bill to release the money as yet. Plaques were presented to Jack Dinsen and Jim Edmondson on Monday night at the fire hall for their 50 years of service in the Fire Department. The Manistee

Township Fire Department 50 Year Anniversary was Tuesday, May 9th and will be celebrated on August 5th.

Treasurer Jankwietz moved to consider Jacob Pete as a Probationary Firefighter for the next two years; supported by Clerk Taylor. All in favor; motion carried.

Treasurer Jankwietz made the motion to accept the bid from Waste Reduction Systems, LLC, and enter into a three-year contract, for weekly trash pickup only; supported by Trustee Dontz. All in favor; motion carried.

Trustee Dontz made a motion to enter into a contract with the Manistee County Road Commission for road repairs on Hill Road at a cost of \$220,873.03 to the township based on the bid from Rieth-Riley; supported by Trustee Finout. In a roll call vote, the Ayes were: Dontz, Finout, Jankwietz, Taylor, and Bjorkquist. The Nays were: None. Absent was: None. Motion carried. The total contract is for \$441,746.06; half is paid by the road commission; half by the township.

Clerk Taylor recommended the Board consider Recommended 2022/2023 FY Budget Amendment No. 1. The budget amendment would re-align some of the operating and fire department expenses for the remainder of the current year. Treasurer Jankwietz made the motion to adopt the Recommended 2022/2023 Budget Amendment No. 1; seconded by Trustee Dontz. In a roll call vote, the Ayes were: Finout, Jankwietz, Taylor, Dontz and Bjorkquist. The Nays were: None. Absent was: None. Motion carried.
